Personal data submitted via this Application Form (M-1) will only be processed by Fédération Internationale de Volleyball (FIVB), Château Les Tourelles, Edouard-Sandoz 2-4, 1006 Lausanne, Switzerland, for carrying out Article 6.2.8 let. a of the FIVB Sports Regulations 2023 which provides requirements for international transfers of Minor players for the protection of minors. Legal basis for this processing of personal data is Art. 6 (1) lit. b and, alternatively, Art. 6 (1) lit. f GDPR.

The personal data is processed and stored for no longer than is necessary for the purposes described above, unless the use of such personal data is further required for ongoing administrative or judicial proceedings or, where necessary, for preventing or detecting unlawful actions. The copy of the passport/ID collected, if any, will be blacked out in the sections that are not necessary for the above-mentioned purposes.

Beyond this, the personal data will not be processed or used, and in particular will not be transferred to third parties without authorization.

The data subjects (i.e., usually Player, parents, contact person of the Receiving Club) have rights against the above-described data processing pursuant to Art. 15 to 21 GDPR as well as a right of appeal to the competent data protection authority pursuant to Art. 77 GDPR.
